Program Mission

The mission of the North Carolina Criminal Justice Fellows Program is to recruit talented high school seniors and graduates into the criminal justice profession. Each year this program will fund fellowships for individuals who have exhibited high academic achievement, a history of service to their school and community, and a desire to serve the state of North Carolina in a field within the criminal justice profession.

The North Carolina Criminal Justice Fellows
Program will provide forgivable educational
loans to participants who agree to enter an
eligible criminal justice profession in North
Carolina. This Fellowship will fund an Applied
Associates Degree in Criminal Justice or other
Committee approved field of study from any
North Carolina Community College. Recipients
who receive the educational loan would have
five (5) years to repay, though it would be
forgiven if they enter and remain in an eligible
criminal justice profession in North Carolina for
four (4) years.



Additional Information

- Applicants are encouraged to begin establishing relationships with agencies they plan to seek employment with.
- This program is meant for those intending to enter an eligible criminal justice profession after earning their associate degree.
- This program is not meant for those intending to pursue a bachelor degree immediately after completing their associate degree.
- Fellows accepted into the program must graduate within two (2) years with their associate degree and remain employed in an eligible criminal justice profession in North Carolina for four (4) years.

North Carolina Criminal Justice Fellows Program

About the Program

- The program provides 100 fellowships each year to students interested in a career in an eligible criminal justice profession.
- Students must attend a North Carolina Community College and must receive their Associate Degree within two (2) years.
- Students will have five (5) years to repay the forgivable loan after receiving their Associate Degree.
- The loan will be forgiven if the student enters an eligible criminal justice profession in North Carolina and works for four (4) years.

Application Process

- The application process opens annually on September 1st and closes on April 30th.
- The application and other program forms can be found on the Department of Justice website at www.ncdoj.gov/cjfellows.
- Applicants will be notified of their selection status no later than June 1st of each year.

Every Applicant Must Submit

- A completed application (to include an application essay describing future career goals in the criminal justice system).
- High school transcripts (GPA & class rank).
- SAT and/or ACT scores (optional).
- At least two (2) references.
- A copy of their driver's license or gov't ID.
- AOC records checks from all counties lived in/charged in.



Eligible Criminal Justice Professions

- State and local sworn law enforcement officers.
- State correctional officers.
- State juvenile justice officers.
- Other correctional officers maintained by local governments, and juvenile justice agencies.
- Sworn Sheriffs and Deputy Sheriffs.
- Detention Officers.
- Telecommunicators under the direct supervision of a law enforcement agency.

Other Program Information

- Applicants must not have been convicted of a felony or any crime as outlined in the Criminal Justice Fellows Program Guide.
- Fellows may reside anywhere in North Carolina and attend any North Carolina Community College while completing their 2-year degree and professional certification.
- Fellows that work for four (4) years in an eligible criminal justice profession following graduation and certification will be eligible to have their Fellows loan forgiven in full.

Program Progression Plan

Application Period

Interested individuals submit their applications August 1 - April 30.
Applications are reviewed quarterly.
Applicants will be notified of their selection status no later than June 1st of each year.

Completing Your Degree

Once accepted into the program, a Fellow enrolls at a NC Community College to pursue a 2-year degree. A Fellow should plan with their advisor to maintain a course load sufficient to graduate within 2 years.

Year 1 After Graduation

Following college graduation, a Fellow has one year to complete a law enforcement, correction, detention, or telecommunicator certification course and secure full-time employment with a criminal justice agency.

Years 2-5 After Graduation

Once employed by a criminal justice agency, a Fellow must work full-time for at least four (4) years to maintain eligibility for loan forgiveness. Upon completion of four (4) years of service, the loan is forgiven in full!

Criminal Justice Fellows Program Overview

Who can apply?

The Criminal Justice Fellows Program is open to high school seniors and graduates seeking an Associate in Applied Science in Criminal Justice or other Committee approved related field of study. Applicants must reside in, attend a community college in, and intend to enter an eligible criminal justice profession in North Carolina.

What is needed to apply?

Applicants interested in the Criminal Justice Fellows Program can visit www.ncdoj.gov/cjfellows or email cjfellows@ncdoj.gov to obtain an application packet. In addition to a completed application, applicants must also submit unofficial high school transcripts, SAT and/or ACT scores, two (2) references, a copy of their driver's license or government issued ID, and AOC records checks from all counties they have resided in or may have been charged in.

When is the deadline?

The application process for the Criminal Justice Fellows Program opens annually on August 1st and closes on April 30th. Selection is ongoing and applicants are encouraged to apply early. Completed applications and all accompanying documents must be received by the April 30th cutoff date. If submitting an application packet via mail, applicants should make sure to mail it early enough to be received by April 30th as we use the date received and not the postmarked date.

Why should you apply to be a Fellow?

The Fellowship can help you to achieve your educational and professional goals by providing funds for tuition, fees, and textbooks and supplies. The maximum fellowship value per student for one academic year (two semesters) is \$3,152.00. Maximum values are as follows:

The total value of the fellowship over two years is **\$6,304.00**. Tuition, fees, books, and items beyond these listed values per semester/over the course of their program are the responsibility of the student. The Fellowship will not pay for courses being retaken due to the student having previously failed or dropped the course.

How will applications be reviewed?

Applications will be reviewed based on five (5) criteria: scholastic profile, writing ability, school and community service, references, and potential for excellence in an eligible criminal justice profession. Applications are reviewed by the Program Manager in the order that they are received and presented to the Committee at each quarterly Committee meeting for selection and admission into the program. Criminal Justice Fellows Program Application Directions

- 1. Fill out the application completely. All fields marked with an * are required and cannot be left blank. Incomplete applications cannot be processed.
- 2. Gather the following documents. These items should be sent along with your application.
 - Unofficial high school transcripts
 - SAT and/or ACT scores (optional but recommended)
 - Two (2) references (to be submitted on the CJFP reference form and/or on official letterhead)
 - Copy of your driver's license or government issued ID
 - AOC records checks from all counties you have resided in or may have been charged in (if 18+ years old)

If using a smartphone to scan your documents, please use a scanning app to scan them into a PDF (**do not** just take photos of your documents). If emailing your application, please send the accompanying documents as attachments.

3. Submit your application and accompanying documents by <u>April 30th at 5:00 pm</u>. Incomplete applications and/or applications received after the cutoff date will not be processed. **NOTE:** If mailing your application, please make sure to mail it with adequate time to be <u>delivered</u> to our office by the cutoff date and time. The following question appears the Employment History and Criminal Record section (p. 4) of the application.

Have you ever been arrested by a law enforcement officer or otherwise charged with a criminal offense? The term "charged" as used in this question includes being issued a criminal citation or summons. If you have questions regarding listing charges, please refer to the application directions. * \square Yes \square No

Answer the question completely and accurately. Any falsifications or misstatements of fact may be sufficient to disqualify you. If any doubt exists in your mind as to whether or not you were arrested or charged with a criminal offense at some point in your life or whether an offense remains on your record, you should answer "Yes." You must list any and all criminal charges regardless of the date of offense and the disposition (to include dismissal, not guilty, *nol pros*, prayer for judgement, or any other disposition where you entered a plea of guilty). Include all offenses other than minor traffic offenses. Specifically include DWI, DUI, driving while under the influence of drugs, driving while license permanently revoked, speeding to elude arrest, or duty to stop in event of accident. These offenses may not disqualify you but need to be stated for review.


